The undersigned states, on information and belief, that Darryon Hakeem Williams, Defendant, did commit a Felony, a violation of PC187(a), Murder, committed as follows:

On or about February 20, 2021, in the County of Contra Costa, State of California, the crime of Murder in violation of PC187(a), a Felony, was committed in that DARRYON HAKEEM WILLIAMS did unlawfully, and with malice aforethought murder Michael Iliff, a human being.

On or about February 20, 2021, in the County of Contra Costa, State of California, the crime of Fleeing A Pursuing Peace Officer's Motor Vehicle While Driving Recklessly in violation of VC2800.2, a Felony, was committed in that DARRYON HAKEEM WILLIAMS while driving a motor vehicle in a willful and/or wanton disregard for the safety of persons, and with the intent to evade, pursuing peace officer's motor vehicle.
