**COUNT 1 – SECOND DEGREE ROBBERY**

The undersigned states, on information and belief, that Philander Raymel Johnson, Defendant, did commit a Felony, a violation of PC211, Second Degree Robbery, committed as follows:

On or about November 24, 2021, in the County of Contra Costa, State of California, the crime of Second Degree Robbery in violation of PC211, a Felony, was committed in that PHILANDER RAYMEL JOHNSON did unlawfully, and by means of force and fear take personal property from the person, possession, and immediate presence of Jonathan Straka.

**ENHANCEMENT 1**

PC12022(b)(1): Special Allegation-Use Of Deadly Weapon

It is further alleged as to Count listed above that in the commission and attempted commission of the above offense, the said defendant, PHILANDER RAYMEL JOHNSON, personally used a deadly and dangerous weapon(s), to wit, Knife, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

**ENHANCEMENT 2**

PC12022.1: Special Allegation-Offense While On Bail Or O.R.

It is further alleged as to Count listed above that at the time of the commission of the above offense, the defendant, PHILANDER RAYMEL JOHNSON, was released from custody on bail or Own Recognizance in Case Number 1-197500-2 within the meaning of Penal Code section 12022.1.

**COUNT 2 – ASSAULT WITH A DEADLY WEAPON**

The undersigned states, on information and belief, that Philander Raymel Johnson, Defendant, did commit a Felony, a violation of PC245(a)(1), Assault With A Deadly Weapon, committed as follows:

On or about November 24, 2021, in the County of Contra Costa, State of California, the crime of Assault With A Deadly Weapon in violation of PC245(a)(1), a Felony, was committed in that PHILANDER RAYMEL JOHNSON did willfully and unlawfully commit an assault upon Jonathan Straka with a deadly weapon, to wit, Knife.

**ENHANCEMENT 1**

PC12022.1: Special Allegation-Offense While On Bail Or O.R.

It is further alleged as to Count listed above that at the time of the commission of the above offense, the defendant, PHILANDER RAYMEL JOHNSON, was released from custody on bail or Own Recognizance in Case Number 1-197500-2 within the meaning of Penal Code section 12022.1.

**COUNT 3 – KIDNAPPING FOR CARJACKING**

The undersigned states, on information and belief, that Philander Raymel Johnson, Defendant, did commit a Felony, a violation of PC209.5(a), Kidnapping For Carjacking, committed as follows:

On or about November 24, 2021, in the County of Contra Costa, State of California, the crime of Kidnapping For Carjacking in violation of PC209.5(a), a Felony, was committed in that PHILANDER RAYMEL JOHNSON did unlawfully and during the commission of carjacking, kidnap Israel Navarette, not a principal in the carjacking.

**ENHANCEMENT 1**

PC12022(b)(1): Special Allegation-Use Of Deadly Weapon

It is further alleged as to Count listed above that in the commission and attempted commission of the above offense, the said defendant, PHILANDER RAYMEL JOHNSON, personally used a deadly and dangerous weapon(s), to wit, Knife, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

**ENHANCEMENT 2**

PC12022.1: Special Allegation-Offense While On Bail Or O.R.

It is further alleged as to Count listed above that at the time of the commission of the above offense, the defendant, PHILANDER RAYMEL JOHNSON, was released from custody on bail or Own Recognizance in Case Number 1-197500-2 within the meaning of Penal Code section 12022.1.

**COUNT 4 – KIDNAPPING FOR CARJACKING**

The undersigned states, on information and belief, that Philander Raymel Johnson, Defendant, did commit a Felony, a violation of PC209.5(a), Kidnapping For Carjacking, committed as follows:

On or about November 24, 2021, in the County of Contra Costa, State of California, the crime of Kidnapping For Carjacking in violation of PC209.5(a), a Felony, was committed in that PHILANDER RAYMEL JOHNSON did unlawfully and during the commission of carjacking, kidnap Troy Vorous , not a principal in the carjacking.

**ENHANCEMENT 1**

PC12022.1: Special Allegation-Offense While On Bail Or O.R.

It is further alleged as to Count listed above that at the time of the commission of the above offense, the defendant, PHILANDER RAYMEL JOHNSON, was released from custody on bail or Own Recognizance in Case Number 1-197500-2 within the meaning of Penal Code section 12022.1.

Complainant requests that the Defendant[s] be dealt with according to the law. I declare under penalty of perjury that the foregoing is true and correct.
